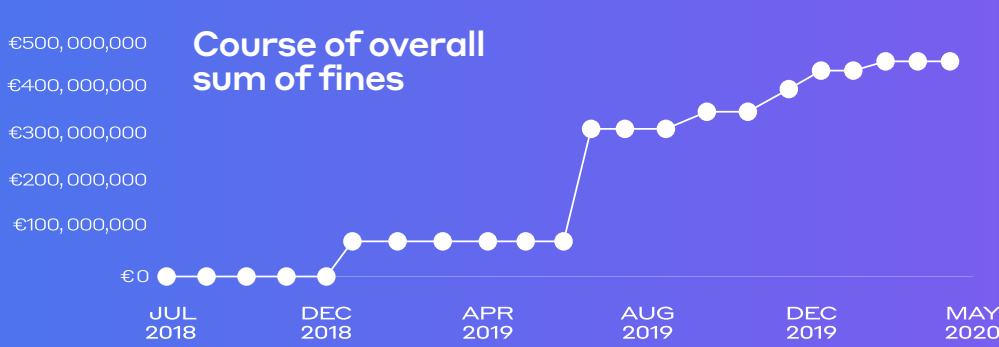
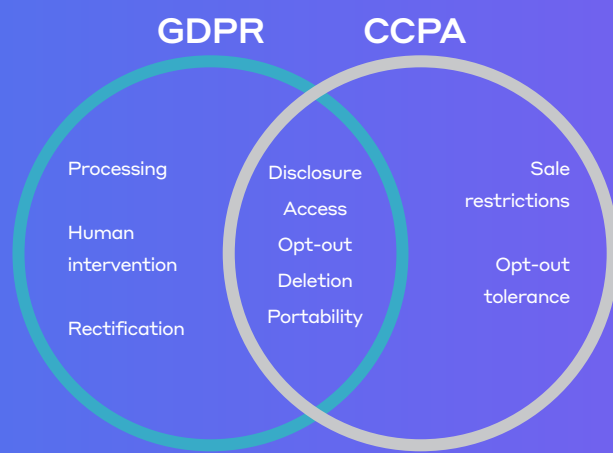

Managed by an impartial network, each request is ordered and encrypted for privacy



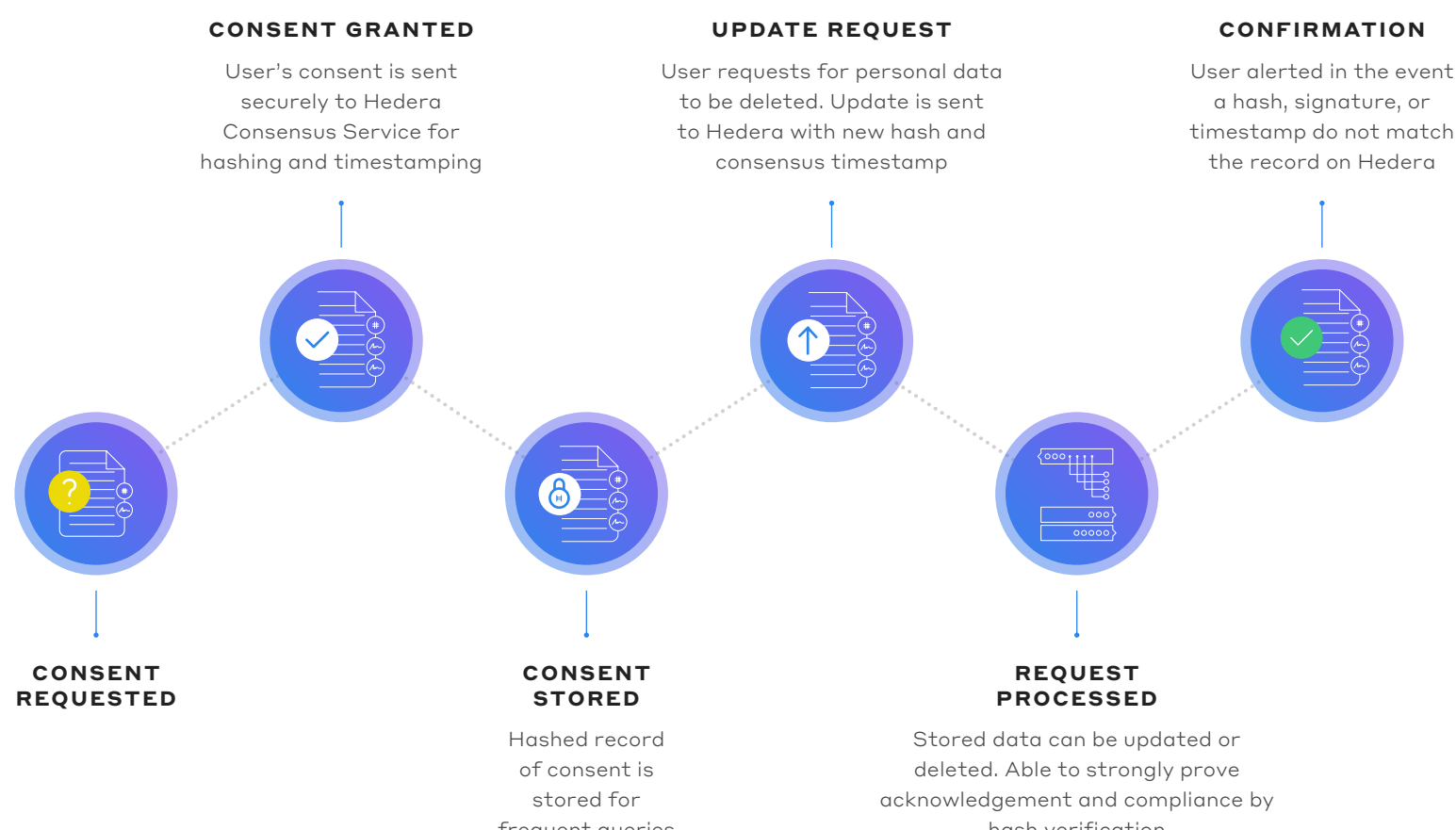

THE SOLUTION

HOW IT WORKS


Upon a user's consent to data use and sharing, the app generates a unique hash of the data, signs it, and stores it using Hedera's tamper-evident log. The data can be made available to consumers or auditors to verify the hashes and signatures of the recorded consent or request for deletion with the audit log to confirm the company's acknowledgement of each request.



THE OUTCOME

Hedera Consensus Service provides consumers, auditors, and companies with secure provable data to manage the lifecycle of data consent. Is the consumer's data authorized to be stored or shared; has a deletion request been delivered and completed? Each update is recorded for evidence of its receipt and its corresponding action.
